Please explain the reasons for your response

The proposal is misquided. Children are not mini adults and therefore need to be treated differently. Having benefited from a short parenting course I have realised that parents in Scotland need support and encouragement to raise well nurtured children. Bringing up children is the most important thing we do. It is difficult to do it well. It is becoming increasingly difficult to do it well with social and economic factors and governmental policies reducing the amount of time parents can spend with their children. Criticism of parenting practice that undermines parental discipline will make the situation worse not better. Children need to be disciplined if they are to become productive members of society. Discipline can take many forms both positive and negative. Both positive and negative forms can be damaging to children. It would be undesirable and indeed impossible to legislate against all forms of harm against children. Actions can be carried out in stressful conditions where the same action could be seen as right or wrong depending on the circumstances and the children involved. Two examples of bad parental practice which do more harm that physical discipline: 1. Parents loosing control and shouting at children leading to unruly children. 2. Parents using rewards so that their children act like mercenaries. I have often been praised for the behaviour of my 3 children. They have been loving disciplined by my wife and myself which from time to time has involved spanking. Excluding a couple of exceptions this has always taken place after the heat of the moment and as part of a conversation allowing the child opportunity to present their case. In my experience, limiting its use and utilising it after the heat of the moment is a very effective form of correction that I would not wish to deprive any parent of. I recognise the problem is that spanking often takes places in the heat of the moment when parents lose control. In this case it does almost as much harm as shouting but at least it usually brings the situation back under control quicker.
