#### Please explain the reasons for your response

In my opinion, any form of physical punishment on a child is assault. I think it is too easy for adults to physically punish i.e. assault children due to their smaller, weaker, non-adult status. Adults do not have the right to physically assault a child's body and the damage that can be caused to them in doing so whether mentally, emotionally or, indeed, physically, is unthinkable and upsetting. I also think it is impossible to place the marginal line as to what constitutes a 'simple physical punishment' and what is deemed as physical harm. The answer is that there is no way of placing a line between each. So why take the risk? Equal protection from assault would make it clear cut that no child should be physically assaulted under any circumstances whatsoever. The absence of this Protection will only continue to make it acceptable to 'smack' by parents and others. You wouldn't smack an annoying work colleague so why should you be allowed to do it to a child.


